

**Summary Table on SHN and Swab Requirements for Travellers to Singapore**

This table summarises the SHN and Swab requirements for approved travellers under the following Safe Travel Lanes, according to the traveller's travel history in the past consecutive 14 days to a certain list of countries/regions:

- Returning Singapore Citizen/Permanent Resident (SC/PR) Lane
- Singapore Citizen/Permanent Resident (SC/PR) Familial Ties Lane
- Student's Pass Holder Lane
- Work Pass Holder General Lane

<p>**Travellers from these countries/regions may opt out of SDF stay and serve the entire duration of SHN at their place of residence, if the following criteria is met:</p> <ul style="list-style-type: none"> <li>• The traveller has not travelled to other country/region other than the above specified list in the last consecutive 14 days prior to departure for Singapore.</li> <li>• The traveller is occupying the place of residence (i.e. residential address) alone, or only with household members with the same travel history, who are also serving SHN of the same duration and period; and</li> <li>• There is no one ordinarily residing at the place of residence (e.g. domestic helper) who does not share the same travel history, and the traveller has already made all necessary arrangements to ensure that any such person will not reside at the place of residence until the end of the SHN period.</li> </ul> <p>Applications must be made at least 3 days prior to arrival in Singapore. For SCs and SPRs, opt-out applications can be submitted <a href="#">here</a>. For other nationalities, opt-out applications may be made as part of entry approval processes.</p> <p>The list of countries/regions eligible for SDF opt-outs will be updated from time to time depending on the public health risk assessment. Travellers must be prepared that any prior approvals granted may be revoked, and the prevailing border and health control measures to apply on arrival, including SDF stays and payments, where applicable.</p>
